In May, GHA announced the commission of a mural honoring those experiencing homelessness in our community and the organizations that offer solutions and hope.

The mural announcement featured remarks from some of the 18 original tent city partners who crafted the 2015 Homelessness White Paper that helped create GHA. #### THE MURAL BLOCK PARTY

GHA Partners and Stakeholders hosted a block party on a hot Saturday in July in the parking lot of Triune Mercy Center. Our mural artist brought assorted cans of spray paint in bright colors, music was playing over a speaker, homemade cookies were served by a local electrical company, shaved ice was available from Greenville High students, corn hole, giant Jenga, giant Connect Four, sidewalk chalk, coloring pages, bubbles, and chairs under tents were set for people of all ages and all walks of life to enjoy – together.

One man sat in a chair watching the festivities, taking it in with his friends who had come for the services available at Triune Mercy Center. He was encouraged to help paint the mural, but he said, "No. I will mess it up." He was assured that his efforts could not mess it up but would add to the layer that Ninja Picasso would build upon. Eventually, he got up, went over to try the spray paint and a big smile erupted across his face as he said, "This is amazing. I feel free!" These words echo the core purpose of GHA's work and the mural...to create a community where we all feel the freedom of being seen, heard, and valued.

#### **AUG 2022**

#### **DEC 2023**

The rendering comes to life as GHA's 5th birthday gift to the community. Seen | Heard | Valued now covers the back wall of Triune Mercy Center's sanctuary and reminds all who pass that homelessness is solvable. Watch the story of how the Seen | Heard | Valued mural was created HERE.

#### **GHA IGNITE EVENTS**

GHA's iGNITE events this year reached more than 375 in person and online attendees. The luncheon, held at First Baptist Church Greenville, included speakers sharing what it means to be seen, heard, and valued and how those words drive the work of GHA. We heard stories from men and women who have faced homelessness and the organizations that helped them find hope. And we learned how to get engaged with innovative solutions in Greenville County.

In celebration of GHA's 5<sup>th</sup> birthday, a special evening event was added. iGNITE the Night VIP event debuted an art exhibit featuring the faces and stories from the **Seen | Heard | Valued** mural and glimpses at Nick Burns aka Ninja Picasso's process in creating the 47-foot-high work of art. The exhibit is open to the public in the lobby of the Camperdown Falls Tower building for the next 6 months. This collaboration with Premiere Arts Collective, Elliott Davis, and TealHaus Strategies offers continued community engagement opportunities into 2024.

Thank you to everyone who made our **iGNITE** events possible. The **Greenville Homeless Alliance** includes individuals and 500+ partner organizations committed to finding solutions to end homelessness. We saw the power of that partnership in our **sponsors**, **volunteers**, **attendees**, and most of all, our **speakers** sharing stories and strategies that remind us that homelessness is solvable in Greenville County when we come together as a connected community.

#### **WORKING GROUP HIGHLIGHTS**

In 2023, more than **60 Stakeholders from 50 different organizations participated in Working Groups**. These groups implement GHA's <u>strategic plan</u> and align with the <u>graph</u> below which shows the conditions that hold a problem like homelessness in place. Working group members and other **volunteers invested more than 880 hours in 2023** to change systems and advance equity by shifting conditions. Here are a few highlights that demonstrate which levels of the graph were impacted.

#### **ADVOCATE WORKING GROUP**

- Refined the Advocacy Training Academy curriculum. Conducted 5 sessions with more than 125 participants including academies for the Southernside neighborhood association and LGBTQ+ community.
- Updated <u>GHA Policy Agenda</u> and engaged in advocacy for issues including the City of Greenville's Development Code, Homeless Court, and affordable housing and transportation funding

#### **INNOVATE WORKING GROUP**

- Began developing a universal exit from homelessness strategy with two dozen different nonprofits (known as <u>Coffee Club</u>) that utilize a variety of data platforms.
- Determination Committee" meeting in collaboration with the Upstate Continuum of Care (CoC) to enhance understanding of the challenges and opportunities of CoC serving 13 counties in the Upstate.
  - Developed criteria to evaluate GHA initiatives.

#### **COLLABORATE WORKING GROUP**

Developed and released the online
 <u>Homelessness Resource Guide</u> in July to simplify the process of getting to the right resources for those experiencing homelessness. Since its release, the guide has been visited more than 2600 times.

#### **EDUCATE WORKING GROUP**

Released the <u>Unsheltered Homelessness</u>
 <u>Brief</u> to offer insight into unsheltered
 homelessness, its causes, and the current
 local solutions. The brief was developed by
 Educate Working Group Members in
 collaboration with members of Coffee Club.

**IMPACTING:** Mental Models (what people know and believe about an issue)

Collaborate and Educate Working Groups joined forces in March to create and implement a Community Engagement Plan. Using GHA's 5<sup>th</sup> birthday and the **Seen | Heard | Valued** mural as a catalyst, the plan included community outreach, social media efforts, targeted education, and hosting several key community events including the Mural Block Party and the iGNITE Luncheon and VIP Reception.

#### **Community Engagement Plan Goals:**

- 1. Increase community awareness and understanding of what homelessness really looks like in Greenville County.
- 2. Increase community understanding of who GHA is and our role in connecting the community to solutions for homelessness.
- 3. Increase the number of community members engaging with GHA.

#### **MORE 2023 HIGHLIGHTS**

- Engaged in advocacy issues addressing affordable housing, mental health, eviction, fair lending, and Homeless Court alongside community partners including Greenville Affordable Housing Coalition, Fair Lending Alliance, Impact Greenville, Greater Good Greenville, GOAL Justice, and Village Engage. These efforts included sending out 9 Call to Action emails encouraging stakeholders to get involved.
- Partnered with GOAL Justice to provide data, solutions, media contacts, engagement with policymakers, and connection to people willing to share their stories of homelessness and attend events organized by GOAL Justice.
- Continued collaboration with BJU
  Cinematic Arts students and LEAP
  Communications to create 60-second

- Partnered with TealHaus Strategies to create the iGNITE the Night event and the six-month exhibit in the Camperdown Falls Tower art gallery depicting the creation of the Seen | Heard | Valued mural and Stories of Hope. This collaboration was provided probono with an estimated value of \$36,000.
- Published a research study with BJU Health Sciences Department and GHA staff titled, "An Aging in Place Approach to Barriers and Facilitators of Shelter Utilization by Older Adults Experiencing Homelessness in Upstate South Carolina". Read the full study HERE.
- Held four quarterly <u>Stakeholder Meetings</u> in collaboration with the Upstate Continuum of Care.


#### PARTNERSHIP CREATES HOUSING NAVIGATOR

In September, DeAndra "DJ" Wilson Hillman joined GHA as Housing Navigator. This position, developed in partnership with the <u>Piedmont Health Foundation</u>, serves as a bridge between frontline service providers and housing providers so people experiencing chronic homelessness who are ready for housing can be connected to available housing options. This pilot initiative creates new opportunities to increase access to stable housing, improve health outcomes, and reduce disparities for our most vulnerable neighbors.

In addition to developing connections, DeAndra is overseeing a centralized housing list. She is identifying challenges and risks experienced by both sets of providers. This collaboration will create a universal database that tracks exits from homelessness for pilot participants.
